This product is intended for use in all crops. The micro-organisms in N-Counter[®]+ have been shown to increase availability of Nitrogen, Phosphorus, and Potassium and can increase plant uptake. Increase nutrient uptake can lead to an increased yield.

DIRECTIONS FOR USE

This product is suitable for all crop types. A single application per growing season is recommended. N-Counter[®]+ is a fully soluble dry powder for liquid in-furrow application or fertigation. This product can be dissolved in water or non-bactericidal compatible inputs. Test for physical compatibility on a sample. Use up any product dissolved in liquid within 24 hours.

APPLICATION RATE BY WEIGHT

Non-legumes: 100 grams/acre Legumes: 33 grams/acre

To measure with a scoop: Shake container as product might have settled during transport. Use the provided scoop to measure the volumes below of the dry powder.

Non-legumes: 5.5 fl oz/acre Legumes: 1.8 fl oz/acre
